PET BOARDING AGREEMENT

This is a contract between Pacetti Road Pet Spa and the pet owner whose signature appears below (Hereinafter called "Owner").

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked out of the facility
2. Pacetti Road Pet Spa retains the right to refuse services to any pet due to aggressive behavior, or any other behavior that could present harm to staff.
3. **Pacetti Road Pet Spa will not be held liable for any damages to toys, beds, sheets, blankets, or other items brought from home. Owner understands that pets may chew and/or soil bedding or toys.**
4. **Pacetti Road Pet Spa recommends Owners bring their pets' own diet from home, however, will feed our IN HOUSE food upon request at no additional charge. By signing this contract, Owner consents to understanding that a sudden change in diet can cause severe stomach upset and/or diarrhea and will not hold Pacetti Road Pet Spa liable if this occurs as a result of Pacetti Road Pet Spa feeding IN HOUSE pet food.**

5. In the event that a pet develops diarrhea, Pacetti Road Pet Spa can provide a nutritional, supplemental, probiotic - added to your pet(s) food - at no additional cost. If you would like Pacetti Road Pet Spa to add Probios® to your pet's diet if diarrhea develops please initial here [redacted].
6. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of Pacetti Road Pet Spa.
7. Owner further agrees that the pet shall not leave the facility until all charges are paid to Pacetti Road Pet Spa
8. Pacetti Road Pets Spa shall exercise reasonable care for the pet(s) delivered by the Owner to facility for boarding. It is expressly agreed by Owner and Pacetti Road Pet Spa that Pacetti Road Pet Spa's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal for any and all acts or behavior of said pet while it is in the care of the facility.
9. Owner specifically represents that he or she is the sole owner of the pet(s), free and clear of all liens and encumbrances.
10. Owner specifically represents to Pacetti Road Pet Spa that the pet(s) has not been exposed to rabies or distemper within a thirty day period prior to boarding. Any possible exposure of this nature during the terms of this agreement will be relayed by Owner to Pacetti Road Pet Spa immediately.
11. All charges incurred by Owner shall be payable upon pick up of pet. Pacetti Road Pet Spa shall have, and is granted, a lien on the pet for any and all unpaid charges resulting from boarding pet(s) at facility. The owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, Pacetti Road Pet Spa may exercise its lien rights upon ten days written notice given by Pacetti Road Pet Spa to Owner by certified mail to address shown on contract. Pacetti Road Pet Spa may dispose of pet for any and all unpaid charges, at private or public sale, at the sole discretion of Pacetti Road Pet Spa, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to recover such costs of board or other charges which are delinquent, plus costs of sale, the Owner shall be liable to Pacetti Road Pet Spa for the difference. All monies realized by Pacetti Road Pet Spa at such sale, over and above the delinquent charges due and costs of sale, shall be paid by Pacetti Road Pet Spa to Owner.
12. Owner has provided proof that pet(s) are up to date on required health requirements and understands that pet(s) may be given a onetime flea treatment (Capstar®) upon admission to Pacetti Road Pet Spa if fleas or flea feces (flea dirt) are seen.
13. If pet(s) become ill, Pacetti Road Pet Spa, at its sole discretion, may engage the services of a veterinarian or administer medication or give other requisite attention to the animal, and the expenses thereof shall be paid by the owner. Though every attempt will be made to contact Owner in the event of an ill pet, Owner pre-authorizes veterinary services to be performed not to exceed \$ [redacted] per pet. (Owner's Initials [redacted]) ←
14. Though all appropriate measures are taken by Pacetti Road Pet Spa to prevent the spread of Bordetella (Kennel Cough) and associated contagious pathogens, Pet Owner understands the vaccines administered for prevention of these illnesses does not provide 100% prevention against all strains of virus. Owner agrees Pacetti Road Pet Spa will not be held liable for any veterinary costs associated in the event of any contracted illness during or after boarding, daycare, or grooming.
15. This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Pacetti Road Pet Spa
16. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
